Re: Your Application to Amend the Town's Zoning By-law Northeast Corner of Ontario Street & Greenlane, Town of Lincoln

The Town acknowledges receipt of the above noted complete application and fee on June 7, 2021. Your receipt is attached.

Staff note that the submitted application proposes a building placement and form that departs significantly from the proposal brought forward at pre-consultation. concerns include:

- The proposed building massing located along the Greenlane frontage at a 10storey height without stepbacks as specified in the Secondary Plan. Transitioning to existing low density stable residential uses to the south should be considered.
- The proposed architectural treatment no longer emphasizes the focal nature of the building corner and nearby Ontario St & Greenlane intersection
- Apartment residential uses are now proposed to primarily front Greenlane instead of townhouses with front doors along Greenlane, resulting in active street frontage concerns.
- Staff previously commented on the lack of commercial space proposed along Greenlane, which has not been sufficiently addressed.

Your application is now under review by relevant government agencies and Town Departments for their comments and information. Staff would appreciate the opportunity to discuss the above concerns with you and the potential to make revisions accordingly prior to public notice being issued for this application. As such, an open house and statutory public meeting have not yet been scheduled.

Such costs shall include all legal, expert testimony and administrative and overhead costs.
